Comments: Deficiency is now compliant. Licensing staff did observe during naptime that the educator was not physically present in the room while children were on their cots. The administrator corrected this immediately during the inspection visit and made a plan for to ensure 2 staff are always present in this room.							

## **General Comments**

Monitoring inspection performed. Jenelle Hanscom (new licensing staff) also accompanied me on this inspection visit. Please update my telephone number on your parent board - 506-429-2028. Licensing staff observed upon entry that the educators posted the March break (6-10th) plan for "March Madness week". The school age children will also be attending full days. Looks like a fun full week of activities. All children were observed in their respective classrooms. More than enough staff were observed on site to meet the ratio in the all the rooms which increases the quality of the program offered. Children were observed involved in a variety of fun educational programming during the visit - exploring water properties (filling and emptying water) into different dishes; other children took turns painting with watercolors made from bingo doppers, children were observed building with magnetic blocks, foam blocks, building towers with small blocks and investigating properties of paint. Children have also been learning about emotions and outdoor adventures.

## **General Comments**

Current programming is posted throughout the centre and it references the goals of the curriculum framework. Babies were acting out the song sleeping bunnies and having fun with their educator. All educators were observed engaged with children. Lots of wonderful positive playful interaction was observed. Educators were observed kneeling down or sitting on the floor with children and heard saying "good job getting your shoes off, awesome, easy, gently, be patient please while you wait for your friends, wow, that was very kind of you to do". Educator addressed a behavior issue by offering the child choices. All children were observed with exception of babies getting ready for outside play. Staff were observed providing lots of assistance with dressing for outside play. Older children were engaged in outdoor play. The temperature remained too cold for the babies and toddlers to participate in outdoor play. The outdoor surface is covered in snow which is packed down making it easier for children to walk around. Children played in small groups indoors and outside.

Todays snack was pancakes and blueberries and ample food was made available.

Licensing staff recommends that educators keep the outdoor bins covered when children are finished playing. This will keep the snow from accumulating on the toys in the bin.
