As per discussed with staff, when leaving the building for lunch and/or breaks including any staff covering for another staff at these times, must be documenting their attendance in each of these classrooms. It was observed that staff document their attendance on the child attendance form but are not signing out when leaving the building or when covering another educator. This also applies to the Administrator to document their attendance daily. Educators corrected this during licensing staff visit.

Comments:	Licensing staff observed ice on the top step leading out of the emergency exit in the Afterschool program room on the top floor. This poses a slipping hazard if children and staff must exit the buliding in an emergency. Please keep the steps free of ice and snow during the winter months.

Monitoring inspection performed.

Upon arrival licensing staff observed some children napping - all the 2's and 3's. The fours who do not nap were creating valentine puppets using Contruction paper, google eyes, hearts, sticks and other shapes and gluing them to the paper. The educator was assisting the children and providing them with the materials. The children decorated the puppets using their own imagination.

Administrative records were reviewed, and child attendance is tracked, fire drills and outdoor maintenance checklist is completed monthly.

This facility also has purchased new child size furniture for each of the classrooms. Lots of loose parts, and all toys, equipment and other materials are assessable to the children. The children are familiar with their surroundings as they knew where to find glue and other materials to create their puppets.

Licensing staff observed recent programming posted throughout the facility which references the goals of the curriculum framework. Some activities children were exploring in January were the properties of snow through touch and sight, digging for gems and working on letter matching, music and movement, and experimenting with colors in the snow for their January frozen theme.

All children were observed waking up from nap and moving onto to after noon activities. Some children were observed working on a puzzle, playing with loose parts, and magnetic blocks. Children were observed dressing
