General Comments
<p>Licensing Staff arrived at the facility to perform a Monitoring Inspection. Upon arrival the 2's class was outside playing and the 3's and 4's were getting ready to join them outside. The children were observed playing on a large airplane structure and on the wooden platform. An Educator was observed adding salt throughout the fenced in playground area as it is quite icy.</p> <p>The transition from outdoor play to inside was smooth. A headcount was conducted before the children returned inside for afternoon snack. The children are encouraged to take their hats, mittens, jackets, snowpants and boots off themselves. The Educators offered help to those who needed it. Proper hand washing was observed before the children sat at the table for afternoon snack. Once snack time was finished, the children enjoyed listening to music, played a fishing game and other board games.</p> <p>The rooms are bright, organized and inviting. Current pictures, learning stories and webbing were observed in all the classrooms. A Saint Patrick's Day sensory bin with green rocks, golden coins and shamrocks was available for the children to enjoy. Each room offers lots of natural light. The cubby area is neat, and the children's belongings are labelled. The Educators were attentive to the needs of the children, patient and used encouraging words as the children hung up their winter clothing and got their indoor shoes on. Allergies are posted in each room and attendance records were up to date.</p>
