General Comments

- Visit to facility for annual inspection, when I arrived to the center the children were in the pool, the ratio was respected in and out of the pool.
- I recommended that the mulch under the climbing wall should be raked to add more protective surface around the structure.
- A new swing was installed in the play ground, no protective surfacing was added under the swing. Director has taken it down during the visit and they will read through the fabricant manual to ensure the appropriate amount of protective surfacing.
- Director is now working on an employees guide. New employees will sign the document in regards of their task and responsibilities and will also sign the declaration stating that they read and understood the act and regulations.
- An evacuation plan in case of fire will be made and posted next to the exterior door of the daycare.
- Medication that needs to be stored in the refrigerator needs to be in a box with a lock.
- a seat for potty training must be added to the washroom.
- Facility is waiting on public health inspection at this time.
