General Comments

- -Morning visit to the establishment for an unexpected monitoring inspection
- -Administrator confirms that infants are not mixed with preschool-age kid, only on rare exceptions in early mornings before 8:30am and at the end of the day after 4:30pm
- -The daily information sheet for infants (0-24 months information about the child's mood, eating schedule, rest time, diaper changing) is completed every day and stored in a file that is kept in the baby's room at the end of the week
- -Children's files have been checked, profile and consent are all completed in due form
- -New employee records have been checked, they contain all required checks and documentation
- -Up stairs room keep their medication in a locked cabinet in the kitchen, while the downstairs room keep their medicine in a locked closet in the two-year-old room in both cases it is inaccessible to children
- -Medication used for anaphylactic shock (EPIPEN) are stored safely (inaccessible to children) but easy to access for staff
- -During the visit, it was observed that all educators are engaged with children at their level providing support and having conversations.
- -The designated napping spaces within the center are the classrooms for children between 15 months to 4 years-old and infants 0-15 months have a separate room (close to the office) for their naps.
- -Infants that are less than 15 months have a designated crib that meets regulations.
- -Staff confirms that all bedding material is sent home every Friday, and washed weekly by the parents
- -Each cot is stored so there is no contact with another napping equipment
- -Each child has an easily accessible space to store their personal belongings, which is labeled with their name and used only for the intended child.
- -Diaper changing station is found in the senior infant's room and in the washrooms located in the basement. Individual space is provided for diapers and changing necessities. Changing tables are equipped with a safety strap and covered with a non-absorbent layer, it is separated from the food preparation and is located one meter or less from a sink and children are always supervised during diaper changing.
- -Diaper changing station is located one meter or less from a sink
- -Children are always supervised during diaper changing
- -During the visit, both infant's group was working on a ghost, one group was painting, and the other one was body tracing a ghost. In four-year-old group, they made a vampire craft, and in the two-year-old group they

made a magic cauldron craft and painted magic bubbles. Finally, in the three-year-old group the interest was the tough tray that they have filled with nature's treasures kids have found during the weekend with their families.

Observations: When arriving at the center children were finishing their snack, once they were done, they all transitioned into activities or free play period. All groups stayed inside since it is raining outside. Lunch was served for all groups, infants and younger preschoolers went down for a nap while the older preschoolers transitioned into a quiet play period.
