One Educator was observed cleaning the tables in preparation for morning snack while the other Educator sang a few songs and did the calendar with the children. The children appeared to be familiar with the daily routine which made for smooth transitions throughout the morning.

Proper hand washing was observed before and after the children had morning snack. Educators were engaged with the children through the entire Monitoring visit, pushing the children on the swings, giving high fives as the children hung up their belongings after returning inside and sitting with the children as they ate snack. The posting board has all required documents, and the classroom was tidy and clean. A fire drill was completed during today's Monitoring Inspection. The children used their walking feet as the exited the school and waited for the Educator to call their name.
