<p><b>General Comments</b></p> <p>Follow- Up Monitoring Inspection Performed.</p> <p>Both rooms had a smooth transition from arriving to the facility, having snack, and preparing for their swim in the YMCA pool. Both groups swim on Tuesdays.</p> <p>The children are familiar with the routine and expectations. The educators have children put their swim bags in a designated space, so everyone is prepared to go downstairs to change.</p> <p>Educators demonstrated an abundance of positive child guidance. Different techniques were used depending on the situation and child- I observed patience, kind and nurturing support, humor, and gentle reminders. In one situation an educator took as much as time that was required to support a child who was upset. She found a quiet space in the room to give the child time to share his feelings and then return to the larger group.</p> <p>Both rooms had new materials present and the rooms have been freshly painted. Children were excited when their educator played a card game with them and there was lots of cheering and celebrating the win.</p> <p>Ratios were maintained at all times.</p>
