Comments: The Quality Assurance Monitor observed that one of the classrooms was missing their attendance sheet. Therefore, the educator was unable to sign in the children as they arrived and left. The educator must ensure that children's daily attendance records are completed promptly and accurately. The educator immediately wrote down the children's arrival and departure times on a post-it note. After a few minutes, the educator found the attendance sheet and added the recorded times. The Quality Assurance Monitor suggest that the attendance sheet be placed by the back door, as this is the primary entrance used.  Deficiency is now compliant
