Comments: Infant Room: One Administration of Medication Consent and Record Form was observed to be not signed by the parent or guardian. Signed consent from the parent or guardian is required prior to administering medication.			
32(1) An operator of a licensed facility shall provide indoor play area materials and equipment that are (a) varied and in sufficient quantity for the number and ages of the children receiving services at the licensed facility.	32(1)(a)	Oct 28, 2025	
Comments: Art Materials are depleted, and materials are kept out of reach of the children. Children do not have opportunity to express creativity and their interests. Materials are to be replenished, kept open, down at the child's level and accessible to the children at all times.			
40(1) An operator of a licensed facility shall ensure that personal belongings of a child receiving services at the licensed facility that are brought to the licensed facility, including combs, brushes, toothbrushes, towels, washcloths, bedding, pacifiers and soothers, are (a) labelled with the name of the child.	40(1)(a)	Oct 28, 2025	
Comments: Two-year-old room - It was observed that diapers and wipes were not labeled. Personal belongings brought into the facility must be clearly labeled with the name of the child to ensure proper identification. Infants- It was observed that an infant bottle was stored on a shelf without a cover and was not labeled with the child's name. Additionally, bottles stored in the refrigerator were not labeled with the child's name. When an infant is receiving services at a licensed facility, the operator must ensure that each bottle is labeled with the child's name and stored with a cover.			

General Comments

A Monitoring Inspection occurred October 28, 2025

The children were observed in both the indoor and outdoor environment. Including transition between the two.

Infant Room: The children were observed eating lunch, having their diapers changed, and engaging in free play before nap time. Lunch today consisted of fish sticks, rice, cucumbers, and corn.

General Comments

Two-year-old room: The children were observed playing outdoors with balls, buckets, and shovels. Indoors, they were observed laying down for nap time. Educators were observed sitting with the children and gently rubbing their backs.

2/3-year-old room: The children were observed engaged in quiet time activities, including painting with paint sticks, playing with playdough, and exploring a Halloween themed water table. Two children were observed napping.

Preschool: The children were observed playing with trains and puzzles, engaging in family life play with little people in the house area, exploring a tuff tray activity with leaves and magnifying glasses, and exploring a Halloween sensory bin containing rice, pumpkins, and scoops, and drawing with an educator at the table.

Educators demonstrated positive interactions by using encouraging language and gentle reminders. They asked open-ended questions, listened actively, and extended children's ideas through conversations.

A clearly visible and prominent area was designated for posting the facility's license, current monitoring reports, and any orders for compliance. Additional documentation observed included incident logs, daily attendance records, daily information sheets, and records of evacuation and monthly fire drills.

A conversation took place with the administrator regarding the following:

- A wooden structure in the dramatic play center was observed to be broken. The educator removed it upon inspection until it can be repaired.
- Educators are to ensure that outdoor materials are consistently available and accessible to children for the entire duration of outdoor play.
- Educators are to ensure that recent documentation is posted within the facility and not solely on Brightwheel.
- Ensuring a daily routine is posted in a clearly visible and prominent place. If daily routines are different from one group to another, they must be posted in each play area.
- Ensuring any substitutions to the menu are noted as they occur. Recommending substitutions be posted alongside the menu to allow parents to know what their child has been offered to eat during the day.
- The wooden stepping stools at the sink in the 2/3-year-old room are splintering and must be repaired or replaced to ensure safety and prevent injury.
- Ensuring the kitchen is inaccessible to children unless directly supervised and must be locked to prevent unsupervised access.
