<p>Toxics are now locked and secured. They are no longer stored in kitchen.</p> <p>The educators who did not have a purposefully planned program now have one. The Early Learning Curriculum Coordinators are working with the educators in facility to enhance their program.</p> <p>Educators stated that they have been going outside both in morning and afternoon. Please ensure that this continues on a daily basis.</p> <p>Child / Staff ratio is now being maintained. For educators in the infant room, the cook covers ratio's during breaks to ensure that there are two staff in the room.</p> <p>Vulnerable Sector check that was missing from Staff file is now current.</p> <p>All educators who have not completed the curriculum orientation and Introduction to Early Childhood Education have been put on a waiting list. Verification is in each of educator's files.</p>
