Professional learning is to be completed in a designated centre for all educators who are working with infants and preschool children. Each educator must complete 10 hours of professional learning between March 1 and February 28th of each year. The Quality Assurance Monitor will be monitoring progress as the year moves forward.

<p>General Comments</p> <p>Upon arrival, the children were engaged in many activities throughout the centre. There were camping projects throughout the 3- and 4-year-old classrooms, cooking activities and experience with planting grass and with seeds were observed. The educators showed pictures of outside activities which included painting in the snow. In the infant room they had the children's markings displayed at their level and also had a word wall with words that each child was saying in the classroom. The educators stated that they also share this with the parent(s) on their Facebook page.</p> <p>To document the children's learning, the children's crafts, pictures, and quotes are posted throughout the facility. Educators are journaling to pre-plan and are using portfolios for the children's artwork. Learning stories are also posted on the walls.</p> <p>Attendance records and infant/toddler sheets are being filled out properly. All potential illness forms, and incident forms are being kept in the children's files. Playground checks are being completed, and a fire drill record is evident. Filing system is organized and complete. All documentation for licensing was easily verified.</p> <p>Child files were complete. There was a staff missing a current vulnerable sector and criminal record check. Once that is forwarded to me, I will be able to recommend the facility for licensing.</p>
