General Comments

Children were playing outside when licensing staff arrived. The educators said they spend a lot of time outside in the summer as children have the opportunity to move around in a larger space and the children enjoy the outdoors. One child kept asking after lunch when they were going outside again.

Educators were involved in play with children throughout the outdoor area and when they came inside between transitions to lunch and naps, if applicable. Educators sat at tables with children encouraging problem solving and collaboration. Invitations were prepared for children not napping after lunch. In the four-year-old room, the children were separated into groups to reduce potential issues and allow each group to receive more individualized activities. Each group was sitting at a table with educators and resources to play with playdough or kinetic sand.

The educators in the two-year old room allowed children to transition from outside before lunch by sitting to sing songs while the second educator took children to the washroom to wash their hands and use the washroom or change diapers. A third educator ensured lunches were heated up and/or prepared for children and placed on individual plates for each child. Children's cots were laid out with their blankets while they were eating and a cot placed in between children for the educator to sit on to help children go to sleep and maintain ratio. The educators ensured children's hands and faces were washed after eating with an individual washcloth for each child.

Educators in the infant room engaged in play with children while a third educator prepared lunches. The educators were down on the floor with children encouraging their play and providing comfort when needed.

Documentation was evident throughout the centre. Each room has engaged in a collaborative art piece that is posted in each room. The educators in the infant room have children's photos present valuing a child's sense of belonging. Children's new words are also recorded on a post-it note and placed under their name on a wall for new words with connections to the curriculum. Documentation posted in the two's room supported the children's interest in bugs with information posters and bug photos. A large sheet of butcher paper showcased a construction zone experience with blocks with children's photos and description. A letter written to a child was

posted on the wall documenting the child's experience and efforts in asking for help. The preschool room had children's artwork posted along with crafts from this week of under the sea. A tree was evident from a celebration of Christmas in July last week. A rhyme of favorite foods was posted and a poster for children and their favorite book. A suggestion was given to highlight children's names in documentation in a different color so children can pick it out and begin identifying their own names and their peers.

New staff files were reviewed, and everything was in order. Child-to-staff ratio was maintained at all times, with extra educators to help with transitions and cover breaks.
