This must be removed from parent handbook and parent agreement form.</p> <p>Discussed with administrator regulations on visiting public pools during the summer.</p> <p>Reminded administrator that food must always be placed in the fridge.</p> <p>Recommended review children's files to ensure that doctors information, addresses of people with permission to pick children and emergency contacts are complete.</p>
