<ul style="list-style-type: none"> -Unannounced monitoring inspection at facility -Ratio was respected during the visit -Some children's files are missing the full address for the emergency contact person, the administrator will contact QAM once all address is updated. -Documentary evidence of the child's learning -Signed consent form is missing in one child's file; all other consents are into the children's files. A consent form will be given to the parents. -Administration of medication record is evident -Medications are locked and inaccessible to children -Medications used for anaphylactic shock are stored safely but easily accessible, but no child is in need of an EpiPen at the moment. -Non-prescribed medications are in the original child safe container with the original label and labeled with the child's name but dosage needs to be written on each container. Pictures will be sent to QAM once all dosages are corrected. -Children who become ill are supervised and separated from the other children and to be picked up within one hour of notification to parents.

General Comments

-Heating in the back room must be increase.

Observations: When getting at the center children were napping or having a quiet time, when everybody was up children got into free play, some were playing with play doh others were into building with large blocks. After school kids arrived from school, some did their wish list to Santa while others were playing with play doh.
