## **General Comments**

- -Morning visit to the establishment for an unexpected monitoring inspection
- -Ratio was respected during the visit
- -Children's files have been checked, profile and consent are all completed in due form
- -All staff records contain required checks and documentation
- -Medication are locked and stored in the cabinet in the entrance they are inaccessible to children
- -Medication used for anaphylactic shock (EPIPEN) are stored safely (inaccessible to children) but easy to access for staff
- -Educators were seen, facilitate children's learning by engaging in play and asking open-end questions.
- -Portfolio which highlights children's learning and development are easily accessible, Create the opportunities for children to revisit, explore their learning.
- -In all rooms, evidence of purposeful planning based on children's interest and learning, invitation, photos and learning stories were posted.
- -Each napping child has a cot that is appropriate for their height and is in good repair
- -Administrator confirms that all bedding material is washed weekly by herself, or some the parents will wash them at home.
- -Diaper changing station is found at the back of the center near the washroom, individual space is provided for diapers and changing necessities. The changing table is equipped with a safety strap and covered with a non-absorbent layer, it is separated from the food preparation and is located one meter or less from a sink and children are always supervised during diaper changing.
- -Diaper changing station is located one meter or less from a sink

Observations: When arriving at the center, children were finishing their snack. They were all asking for a dance party, so once everybody was done eating, disco light was put on and Halloween music started, dance party was on. They then transitioned into free play, drawing, crafting and getting all dressed up has a superhero and princess. When I was leaving, they were getting ready for lunch. They didn't go outside to play since it was raining hard early this morning and everything was still wet, staff was planning on going after nap.
