Monitoring inspection opened during visit to follow-up on previous non-compliance and a request for change.

- Taken out of the facility whenever children leave the building.

Children were observed indoors and outdoors during inspection.

As was discussed with administrator on-site, the maximum number of children in the forest school and using the forest school buildings cannot exceed the measured floor space for the indoor play area. Each forest school building measures for 9 children. As per the license issued to the facility, the number of children cannot exceed 42 in Lisa's Playhouse and 18 in the forest school.

Job description in one staff file was not accurate for role. Job description must be amended to reflect the actual role and responsibilities of staff.
