Comments: In 1 of the 12 child records verified, the address of the medical practitioner is missing. The child record file must include the name, address and telephone number of the medical practitioner. The operator must make sure that all child records are complete.

Comments: In 2 of the 12 children's profiles verified, the emergency contact address was incomplete. The child record files must contain the name, address and telephone number of at least 2 emergency contacts. The operator must ensure that all child records are complete.

Comments: 3 out of 12 child records are missing the immunization record or a copy of the exemption. The child record must have a copy of the immunization record or a copy of the exemption. The operator must ensure that all child records are complete.

Comments: In the 12 child profiles verified, the consent for bathing or showering in the event of illness or soiled clothing is missing. All child profiles must contain the signed consent for bathing or showering in the event of illness or soiled clothing. The operator must ensure that all child records are complete.			
27 An operator of a licensed facility shall obtain the written consent of a parent or guardian of a child receiving services at the licensed facility before doing any of the following: (f) permitting the child to participate in an outing.	27(f)	Jan 21, 2026	
Comments: Today, the children were going sleighing in the snow on the property of the farm beside the facility. The Quality Assurance Monitor asked the Administrator if a consent form was signed by the parent or tutor since this is an outing off the premises. The Administrator informed the Quality Assurance Monitor that no outing form was signed by the parent or tutor, however, the parents were made aware of the activity with a calendar sent to them for the month of January. A consent form must be created in order to have the parent's or tutor's permission when going on an outing that is off the facility's property.			
47(1) An operator of a licensed facility shall refuse admission to a child if satisfactory proof of the immunizations required by the Public Health Act or the regulations under that Act is not provided.	47(1)	Jan 23, 2026	
Comments: 3 out of 12 child records are missing the immunization record or a copy of the exemption. The child record must have proof of immunizations or an exemption prior to the child's entry. The operator must make sure that all child records are complete prior to the children's entry.			

General Comments
The Quality Assurance Monitor is on site in the morning to conduct a monitoring inspection. The ratio was respected during the visit.
The Quality Assurance Monitor verified the following items:
<ul style="list-style-type: none"> <li>- If all required documents are posted in a visible and prominent place in the facility.</li> <li>- Child profiles</li> <li>- Signed consent in the children's profiles</li> <li>- Incident records</li> <li>- Indoor play area and materials</li> </ul>
The Quality Assurance Monitor had a discussion with the operator regarding a daily mandatory singing of the Oh Canada national anthem. The Quality Assurance Monitor explained to the operator that the facility can't enforce this to the children. The daily activities of a licensed facility must be planned to express creativity and interests demonstrated by the children. The Quality Assurance Monitor recommends reaching out to their early learning consultant for further guidance.
The Quality Assurance Monitor had a discussion with the administrator regarding designation requirements. The administrator confirmed that the Quality Improvement Plan is current, and all eligible educators are actively completing their required 10 hours of professional learning per renewal year.
The Quality Assurance Monitor observed the children eating their morning snacks and then transitioning to the outdoor play area. Today was sleighing and hot chocolate day. The children were then observed transitioning to lunchtime (lunchbox) and then to nap time. The preschool kids who don't nap went sleighing on the farm property. Positive interactions were observed between educators and the children.
