planned a special outing and got written consent by text message from parents but nothing was placed in the child's file. This was the first occurrence Inspector advised operator that a written consent must be signed by each parent before an outing occurs. Operator will get consent forms signed before next planned outing.

During time of inspection children were observed doing paint, having snacks and enjoying the books available in the craft area. The operator's granddaughter was on site during time of inspection. Positive interaction were observed between the operator and the children.
