Comments: Diaper changing procedures are posted, however inspector observed that not all steps were followed. During the inspection, inspector observed Operator change a child's diaper. Inspector observed Operator place a 2nd child on the diaper changing station without disinfecting the area between diaper changes. This was addressed with the Operator, who disinfected the area immediately. Deficiency is now compliant

Comments: Inspector observed that some absence codes are not indicated on the attendance records when children are absent. Operator must ensure that the absence codes are indicated consistently in order to determine if the child is absent due to illness or other reasons. This information was added immediately. Deficiency is now compliant

Comments: During the renewal inspection, Inspector observed an infant drinking out of their sippy cup unsupervised. Infants must be supervised at all times when eating or drinking. This was addressed with the Operator immediately, who placed the sippy cup elsewhere until they could ensure supervision. Deficiency is now compliant								
General Comments								

During the renewal inspection, inspector observed children engaged in various activities, such as playing with Play-doh, trains, connecting blocks as well as paint. Inspector observed children eating pizza for lunch. Inspector observed the rest period. One child was resting while the Operator was reading stories with the other children.

Inspector observed positive interactions between the children and the Operator, such as getting on their level to play with them, as well as comfort them when needed.
