### General Comments

Visit to facility for the annual inspection, ratio was respected during the visit.

Dicussed with director COVID-19 policies and procedures, reviewed daily logs, bubbles and cleaning schedule. Recommended that director and staff review the cleaning procedures for toys and materials used by the children. Reminded them that anything cloth has to be washed daily or rotated.

Recommended that director review the owners manual for the climbing structure in the preschool outdoor play area to ensure proper amount of protective surfacing. Also recommended the operator check for proper insurance coverage when using this type of climbing structure.

## General Comments

Literacy area should be added to infant play area. Books should be within their reach.

Various types of documentation is present in each room. Recommended that educators document their observations along with their planning.

Discussed rest area for infants and reviewed with the director and educators the regulations on playpen use. Advised the infants sleeping in playpens must be supervised at all times and the 15 minute check cannot be used unless they are sleeping in cribs.

Reminder to set up shade in infant area due to warmer weather approaching.
