Presently there are 11 educators that work at the centre. 4 educators have completed their ECE. 2 educators are in the process of completing their work integrated program and began in November 2021. 2 educators completed their 90 hours. 3 educators are enrolled for their 90-hour course that will begin in September 2022.

General Comments

- Visit done at establishment in the morning for a monitoring inspection.
- The ratio was respected during the visit.
- The following activities were observed:

Infant room: During the free play activities the educators were discussing with the children at their level.

Naptime was also observed during the visit.

Two-year-old room: Free play and story time.

Three and four-year-old room: Some children were creating a cabin with the educator other children were playing a game of hide and seek. "Where is the chicken?"

- The children did not go outside to play due to the extreme windshield.
- Lunchtime was observed in all rooms.
- In all rooms evidence of purposeful planning based on children's interest and learning, invitation, photos and learning stories were posted.
- I observed that the educators used positive child guidance technique, they are respectful to each child rhythm and attentive to their needs.
- The educators files include all pertinent information.
- Discussion with operator concerning qualification and training. Presently 4 educators have completed their ECE, 2 educators are completing the work integrated program, 2 educators registered to complete their 90 hours in September 2022. We also, discussed the parent committee.
