Naptime was also observed during the visit.            Two-year-old room: Free play and story time.            Three and four-year-old room: Some children were creating a cabin with the educator other children were playing a game of hide and seek. "Where is the chicken?"</li> <li>- The children did not go outside to play due to the extreme windshield.</li> <li>- Lunchtime was observed in all rooms.</li> <li>- In all rooms evidence of purposeful planning based on children's interest and learning, invitation, photos and learning stories were posted.</li> <li>- I observed that the educators used positive child guidance technique, they are respectful to each child rhythm and attentive to their needs.</li> <li>- The educators files include all pertinent information.</li> <li>- Discussion with operator concerning qualification and training.
