Visit to the facility to complete annual inspection. Ratio was respected at the time of the visit. Discussion with operator: First Aid Supplies checklist and monthly review and maintenance plan for the outdoor stationary equipment must be completed monthly.

Operator provided a copy of CPR certification for 3 staffs and a copy of a negative Social Development check that was missing. Operator also provided a photo of the medication with the childs name and dosage.

Observations:

The infants were into free play when I arrived while the preschool kids were outside. The preschool kids came in and all children had lunch. Children used the washroom and washed their hands. Educator said that the infants would be going outside after nap time.
