General Comments

Licensing Staff arrived at the facility to conduct a Monitoring Inspection. Upon arrival, the 2 and 3-year-old children were playing outside in the fenced in play area while the children in the 4-year-old class were inside engaged in a variety of activities. Outside the younger groups were observed shoveling snow and making snow angels. The children were eager to show Licensing Staff the different colored frozen ice balls they had made. Later in the morning the groups transitioned back inside for free play. Diapers were changed and hands were washed as the children entered the classroom.

The indoor environment was bright, organized and welcoming. Each child had their own labelled hook and space to store personal belongings. Downstairs in the 4-year-old classroom webbing, learning stories and pictures of the children were posted throughout the room. The children recently read "The Rainbow Fish" by Marcus Pfister. This morning the children were observed making their own rainbow fish, using paint, googly eyes and tinfoil. Another area of the classroom had a large sensory bin filled with blue water, plastic fish, plastic turtles, a small fish net, and jugs. Several children were observed laughing and using their imagination as they played with the fish in the water. Others were observed playing with sand, using spoons and shovels to build sandcastles and other buildings. Throughout the morning the children freely explored the different areas in the classroom. The Educators were attentive and engaged with the children in their activities. One Educator was observed calmly guiding and supporting peers who were having a disagreement. The Educator knelt down next to the children, using a soft and kind tone when speaking with them.

Only positive child guidance was observed during today's Monitoring Inspection. The Educators were attentive to the needs of the children and were observed singing, dancing and rubbing the children's back as they fell asleep for nap time. A conversation was had on site regarding materials in the 2-year-old classroom. Some shelves were empty as containers were being used for other purposes. Please ensure the children have access to a variety of play materials at all times, such as mark making materials, loose parts, vehicles, blocks etc. Please send your Quality Assurance Monitor an email with photos once more materials have been added to the classroom. A small rip was observed on a change pad in the upstairs bathroom. Please discard the ripped change pad and have it replaced as soon as possible.
