Comments: During the follow-up inspection, the inspector observed that a new employee does not have a copy of a valid first aid (FA) certificate and a valid cardiopulmonary resuscitation (CPR) certificate. The operator must ensure that a copy of a valid first aid (FA) certificate and a valid cardiopulmonary resuscitation (CPR) certificate is maintained in the educator's file.			
28(3) The premises of a licensed facility shall comply with (a) lighting, ventilation and other general health standards under the Public Health Act.	28(3)(a)	Oct 24, 2023	Nov 29, 2023
Comments: The inspector observed that the children washed their hands upon entering the facility following outdoor play. Deficiency is now compliant.			
30(3) An operator shall maintain the indoor play area of a licensed facility to ensure the safety of the children.	30(3)	Nov 06, 2023	Nov 29, 2023
Comments: During the follow-up inspection, the inspector observed that the tiles in the infant's bathroom have been repaired. The inspector also observed that the wall in the 2 years old room has been painted. Deficiency is now compliant.			
31(3) An operator shall maintain the outdoor play area of a licensed facility to ensure the safety of the children.	31(3)	Oct 24, 2023	Nov 29, 2023
Comments: During the follow-up inspection, the inspector observed that the Big Dig sand digger has been removed from the top of an outdoor playhouse. Deficiency is now compliant.

Comments: During the follow-up inspection, the inspector observed that a variety of art materials have been added to the 2 classrooms which were lacking art materials. Deficiency is now compliant.			
32(1) An operator of a licensed facility shall provide indoor play area materials and equipment that are (b) arranged on low, open shelves and accessible to the children receiving services at the licensed facility,	32(1)(b)	Oct 24, 2023	Nov 29, 2023
Comments: During the follow-up inspection, the inspector observed that art materials and books are accessible on low open shelves in all the classrooms. Deficiency is now compliant.			
33(2) Stationary equipment in the outdoor play area shall be surrounded by a protective surfacing and installed according to the manufacturer's instructions.	33(2)	Nov 08, 2023	
Comments: During the follow-up inspection, the inspector observed that protective surfacing is lacking around the 3 outdoor play structures. The operator must ensure that stationary equipment in the outdoor play area is surrounded by appropriate protective surfacing as prescribed in the manufacturer's manual.			
39(2) A licensed facility shall have a separate locked storage space that is inaccessible to the children for each of the following: (a) toxic products, chemical products and cleaning supplies;	39(2)(a)	Oct 24, 2023	Nov 29, 2023
Comments: During the follow-up inspection, the inspector observed that all toxic products are locked and inaccessible to children. Deficiency is now compliant.			
40(1) An operator of a licensed facility shall ensure that personal belongings of a child receiving services at the licensed facility that are brought to the licensed facility, including combs, brushes, toothbrushes, towels, washcloths, bedding, pacifiers and soothers, are (c) stored separately for each child.	40(1)(c)	Oct 24, 2023	Nov 29, 2023
Comments: During the follow-up inspection, the inspector observed that children's shoes are stored separately on a shelf. Deficiency is now compliant.			
43 An operator of a licensed facility shall not permit hot beverages in areas that are occupied by the children receiving services at the licensed facility, including the outdoor play area.	43	Oct 24, 2023	Nov 29, 2023
Comments: The inspector did not observe hot beverages in areas occupied by the children. Deficiency is now compliant.			
46(1) An operator of a licensed facility shall only administer medication to a child receiving services at the licensed facility in the following cases: (c) if the medication is not prescribed, the medication is (i) in the original container with the original label, (ii) in a container with child protective caps (iii) labelled with the child's name and the dosage.	46(1)(c )	Dec 01, 2023	
Comments: During the follow-up inspection, the inspector observed that a bottle of Sambucol is not labelled with the child's name. The operator must ensure that non prescribed medications is in the original child safe container with the original label and labelled with the child's name and dosage.			
48(4) If an infant is receiving services at a licensed facility, the operator shall (b) ensure that an infant who is bottle-fed is not fed in a crib.	48(4)(b)	Oct 24, 2023	Nov 29, 2023
Comments: The inspector did not observed any children laying down with bottles on their cots. Deficiency is now compliant.			
48(5) If more than one bottle-fed infant is receiving services at a licensed facility, the operator shall ensure that each bottle is (a) labelled with the child's name, (b) used only for the intended child.	48(5)	Oct 25, 2023	Nov 29, 2023
Comments: During the follow-up inspection, the inspector observed that all the infant bottles are labelled with the children's names. Deficiency is now compliant.
