Children were observed painting, at the outdoor paint center. Children were also observed riding cars, playing with dolls, and picking, and then planting, the freshly picked dandelions, in a garden.</p> <p>Upon entry into the facility, children were observed washing their hands. Several forms of documentation were observed throughout the facility - photos of the children, learning stories, children's artwork, etc. Several well-defined learning centers were observed, both and up and downstairs.</p> <p>Upstairs - Children were observed sitting at a table, painting with watercolors. A small group of children were also observed standing, painting at an easel.</p> <p>Downstairs - Children were observed getting ready for lunch.</p> |
