### General Comments

Licensing Staff arrived the facility to conduct the annual Renewal Inspection. Upon arrival, the children were transitioning to the outdoor play space. The children walked along the side of the building and lined up at the back of the facility to discuss the plan for the morning.

The group began the morning by playing a game of Fishes and Whales. Later on, the children divided into two smaller groups, with one group participating in a soccer game while the other group played basketball in the fenced-in court. Once the games were completed, the groups switched activities to ensure all children had the opportunity to participate in both soccer and basketball.

While outdoors, Educators were heard providing reminders to the children to take water breaks. Prior to transitioning back inside for mealtime, the children divided into two groups. Once inside, the children naturally divided themselves into three groups for mealtime. The children were provided with ample time to eat, and as they finished their meals, some groups were observed engaging in card games as they waited for their peers to finish.

Following mealtime, the children packed away their lunch boxes and refilled their water bottles in preparation for outdoor free play. Before entering the wooded area, the group went over the rules and boundaries for safe play. One Educator explained that the children had been working collaboratively to build forts. The children were observed negotiating, trading, problem-solving, and working cooperatively as they used rocks, branches, and other natural materials in their fort-building activities.

Throughout the Renewal Inspection, only positive child guidance techniques were observed. Educators were heard providing reminders and encouragement to the children and informing them that they could seek support from an Educator when assistance was needed to navigate peer conflicts. Staff and child profiles were reviewed and were found to contain all required documentation.

Licensing Staff recommends renewal.
