The indoor learning environments are well organized. Props, materials, equipment and surfaces are maintained clean while following a COVID-19 cleaning schedule.

The preschool children were observed to be very engaged in play within the interest centers with accessible

activities. They appeared to be happy to be with one another as a bubble group. This is the second week of preschool and the children are learning about the routine of the day. Transition times went smoothly and the children showed excitement with change in activity.

Documentation of the children's learning has begun and implementation of the NB Curriculum Framework is evident. Educators are building relationships with the children while showing enthusiasm for their interests and ideas. Reminder for the school age educators to ensure open-ended art is being encouraged to allow the children to express individuality and creativity. Discussed possibilities for documenting school age programming.
