<p><b>General Comments</b></p> <p>Children had just arrived from school when licensing staff arrived. A Christmas ornament invitation was set up in the craft room, snacks available in one area of another room with tables, and a puzzle set up on a table for children. The educators held a group meeting to ask the children where they were going to play today noting the invitations available, snack choices, and the rest of the activities in the facility. Children would take their laminated name, stating which room they were going to and post their name in the room to limit the number of children. Curriculum areas were well represented throughout the facility with a selection of related books available in each space. Posters related to science, space, and plants were also posted.</p> <p>The facility has created a new routine around snack time allowing children to decide when they would like to eat choosing either their own snacks or ones provided by the centre which allows children to have a choice and read hunger cues.</p> <p>Documentation was posted throughout the facility representing the children's artwork, a self-portrait wall with additional written information about each child, and a collaborative poster created with the children of unacceptable words and comments. The educators stated the children return to the poster to remind peers of unacceptable words and continue to add new comments. A suggestion was made to build on this poster with one with acceptable words for the children to use in celebrating one another and their successes.</p> <p>Children cleaned up and got ready to go outside at 4:45 with all their supplies so parents could easily pick up from outside. Staff files were reviewed and a reminder given to have the bus driver's file on site and complete contents of any relief staff. The educators were observed in discussions with children, providing encouragement, and responding to questions and requests.</p>
