Comments: Inspector observed that educators did not bring the daily attendance record with them when they left the building to go outside. As per the Operator Manual, attendance records must be taken out of the facility whenever the children leave the building. This was addressed with an educator, who brought the daily attendance record out immediately. Deficiency is now compliant			
39(2) A licensed facility shall have a separate locked storage space that is inaccessible to the children for each of the following: (a) toxic products, chemical products and cleaning supplies;	39(2)(a)	Mar 28, 2023	Mar 28, 2023
Comments: During the renewal inspection, inspector found three bottles of shaving cream and a bottle saline solution in a drawer in a classroom. All toxic products must be locked. An educator placed these under lock and key during the inspection. Deficiency is now compliant			
41(1) A licensed facility at which services are provided to children who wear diapers shall have a sturdy surface that is (a) equipped with rails or safety straps.	41(1)(a)	Mar 28, 2023	Mar 28, 2023
Comments: Inspector observed that the changing surface is equipped with safety straps. However, Inspector observed that these were not used during a diaper change. A discussion was had with the educator, who used the safety strap immediately. Deficiency is now compliant			
8(2) The maximum number of children who may receive services at a full-time or part-time early learning and childcare centre, as indicated on the licence, shall not exceed 60 children, including the children of the operator.	8(2)	Mar 28, 2023	Mar 28, 2023
Comments: During the renewal inspection, inspector observed that the maximum number of preschool children at the facility exceeded what is shown on the licence. A discussion was had with the educator and proper measures were taken to ensure that the maximum number permitted was respected. Deficiency is now compliant  Should the administrator wish to re-allocate their spaces, a change in service request must be submitted to their Quality Assurance Monitor.			

## General Comments

During the renewal inspection, inspector observed children playing outside, eating lunch, eating snack as well as free play. Inspector observed educators singing songs with children as well as getting on their level to interact with them. Inspector observed educators using words of encouragement with the children. Inspector observed documentation of the children's learning posted on the walls as well as in each child's portfolio.

A discussion was had regarding ensuring increased supervision in the kitchen area of the facility, to ensure the safety of all children. A discussion was also had with regards to the use of the stationary equipment in the outdoor play area during the winter months. Inspector recommends that the stationary equipment not be used during the winter, as there is not protective surfacing due to the presence of snow. A discussion was had with an educator, who indicates that precautionary actions are taken when they permit the children to use the stationary equipment in the winter months.
