General Comments

A Monitoring Inspection was completed this morning.

Children were observed during their lunches, getting ready for nap, and during free play. Today's lunch was rice casserole. Children were observed sitting at tables in the lunch area, eating their lunches.

Infants- Children were observed finishing their lunch and getting ready for nap time. The infant classroom was observed. The room had a variety of toys and activities. Educator stated that the infants are presently

interested in books, teething toys, balls, and climbing. Several forms of documentation were observed throughout the classroom - learning stories, photos, and artwork.

Two's - Children were observed eating their lunch. After lunch, the children were observed getting ready for their nap. The classroom was observed prior to nap time. Cots were at least 46cm apart.

Tots - The tots were observed eating their lunch. The tot's classroom was not observed today.

Three's - Children were observed eating their lunch. The 3's room was observed. Several activities and toys were observed, but more well-defined centers are required. The arts and crafts center had several materials. Several building accessories were observed, but they were spread out throughout the room. The dramatic play area was lacking in materials. A mirror, a crib, and babies were observed. A conversation is to be had with children, to see what their interests are, and materials and supplies are to be added. Several forms of documentation were observed - learning stories, photos, and artwork.

Pre-K - Children were observed eating their lunch and then playing in Kid Zone. While in Kid Zone, children were observed riding cars, climbing, building with waffle blocks, and balancing on stepping-stones. The Pre-K classroom was observed. Several well-defined learning / play areas were observed. Several forms of documentation were observed - learning stories, photos, and artwork.

Attendance records were observed and they were accurate.

The parent board was observed. Daily routine, weekly menu, evacuation procedures, name of administrator, name and telephone number of QA Monitor and Inspector, board members, allergies, and previous inspection reports were observed.

New staff files were observed. Three staff files were missing proof of being registered for the on-line introduction to Early Childhood Education course. One staff file was missing their First Aid Certificate.
