<b>General Comments</b>
<p>On the morning of the monitoring visit children were preparing to go on a field trip for a science demonstration at a nearby church. Before leaving for the trip both groups had circle time, sang songs and discussed the calendar.</p> <p>The educators planned a March Break Carnival Week with many activities- Little Chefs Day and Beach Day were two of the themes. The educators have been printing off photos each day to document the learning. The displays in the hallways and on the doors of the rooms were well-thought out and include artwork, photos, and quotes from the children.</p> <p>Positive child guidance was observed. Educators were friendly, attentive and patient with the children. Gentle reminders were provided to use words to communicate with friends, share and follow routines.</p> <p>In the 4's room, the children have their family photos taped to their spots at the table. In the 4/5 room, the children's names are written out at their place at the table.</p> <p>Attendance records were complete, and educators have been using the codes to mark absences.</p> <p>Before lunch in the three's room, educators ensured that children using the toilet washed their hands. Diapering was observed and the educator followed all procedures.</p> <p>In the 4/5 room, the educator and children were seeing which zodiac sign they had while the other educator prepared the lunch plates. Lunch today was chicken wraps, apples, cucumbers and mini carrots, with milk.</p> <p>Educators sat with children while eating and discussed the morning field trip and different activities children</p>
