| <p><b>General Comments</b></p> <p>Licensing staff arrived to conduct a monitoring visit as the children were lining up to go outside for snack and group games. The children had snack, applied sunscreen and made sure that they all had their water bottles. The group played Zombie tag and had free play. The educators knew the children very well and they were familiar with their likes and dislikes. This was very apparent as they played different games with them such as "What do you Meme?" and other games. They set up blankets in the shade to play their games on, and staff reminded them to hydrate regularly.</p> <p>Supervision was excellent and staff treated the children respectfully but were also very clear on the rules and boundaries. As a result, the children were respectful of the rules, of the educators and of each other and the atmosphere was pleasant and harmonious. The outside play area is toward the back of the church, and it has a paved area with a small hill, grass and trees, a climbing dome with sand under it, a basketball net, and storage for their outdoor toys. The children took turns with scooters on the little hill, which is steep enough to be fun but not enough to be dangerous. They also wore helmets when on the scooters. They were very good at taking turns and their educators monitored this to ensure fairness. When they had free play some of the children chased grasshoppers and crickets, drew on the pavement and practised writing their names in cursive.</p> <p>There is a parent board in the entryway with all the necessary postings. Schedules are printed for the parents to take, and the staff also have their First Aid certificates on the board. Staff took their attendance forms out with them, and they have a First Aid kit inside. A third staff arrived at lunch time which enabled the educators to rotate in the group to do planning, arrange activities and do administrative tasks.</p> <p>The indoor play area is situated in the basement of the church. It is clean and cool with an abundance of materials. Staff rotate toys inside and outside to keep everything fresh and interesting. They have puzzles, arts and crafts, lego, tables set up with games, drawing paper and markers, books, farm buildings and plastic animals and barbies to name a few. After lunch everyone comes in for quiet time and to cool off.</p> |
