Comments: This is a 3rd visit that the medical information is missing in 1 out of 3 child's files verified. The administrator must ensure that all child's files are completed.

Comments: The documents were not retained at the facility for a year. As the records were no longer available, the inspector discussed with the administrator the importance of maintaining all documentation and ensuring that copies are properly kept moving forward. Deficiency is now compliant.
