<p><b>General Comments</b></p> <p>A monitoring inspection was conducted in the morning of February 17, 2026</p> <p>The children were observed in both the indoor and outdoor environments, including during transitions between the two. Additionally, the children were also observed eating snack, with handwashing occurring beforehand.</p> <p>Indoors, the children were observed playing with trains, building with Lego blocks, drawing, singing, looking at books, and playing with baby dolls. Outdoors, the children were observed climbing and sliding down the hill, digging with shovels and scoops, and jumping in the snow.</p> <p>The operator indicated that the children are currently interested in trains and cars, specifically play dough, and dramatic play.</p> <p>Several forms of documentation were visible, including photographs, and children's artwork. The rooms were well organized and inviting, offering a variety of appropriate materials, books, and toys.</p> <p>The operator demonstrated positive interactions with children by using encouraging language and gentle reminders. The educators asked open ended questions, listened actively, and extended children's ideas through conversation.</p> <p>A clearly visible and prominent area was designated for posting the facility license, current monitoring reports, and any orders for compliance. Additional documentation observed included incident logs, daily attendance records, daily information sheet, and monthly emergency evacuation and fire drill records.</p>
