<p><b>General Comments</b></p> <p>Began the facilities annual inspection on August 26th, no children were present as facility was not yet open. The facility has been closed since March 2020 due to COVID-19. The facility will re-open in September 2020 for the afterschool program. Will need to re-visit to view child profiles and first aid kits. The preschool program will re-open in October 2020.</p>

General Comments

Reviewed COVID guidelines and procedures with the director. The afterschool program will be divided into two bubbles of 15. Discuss entry points, washrooms, cleaning schedule and screening of children.

Last year the facility was granted an exemption to use the neighbouring park as their designated play space for the preschool aged group. Since this winter this area has not been maintained. Therefore a new play area will need to be maintained.

Visited the facility again on September 29th. Ratio was respected and inspection was completed. Operator has found an alternative fenced in outdoor play area for the preschool children.
