## **General Comments**

A Monitoring Inspection was completed this morning. It was a rainy morning, and children were observed during snack and inside play. Attendance records were observed for both groups, and they were accurate, showing the number of children present, and staff. Monthly emergency evacuation and fire drill document was observed. The September 2024 drill was not recorded. Allergy information was observed on the parent board, as well as the daily schedule, Renewal Inspection reports, and the most recent Monitoring Inspection report. Contact information for licensing was also observed. Upstairs – At QAM's arrival, children were observed sitting at their table, eating snack. After snack, children were observed taking part in a variety of activities, some of which included the following: building, Hot Wheels, cutting practice, making painted handprint turkeys, and mark making. Downstairs – At QAM's arrival, children were observed finishing their snacks. A conversation was had with educators on both levels regarding more openended art activities. Some documentation was observed today, but being October, educators are still in the process of showcasing their activities. Children's portfolios were observed, and several pieces of artwork / crafts / worksheets were observed. Positive child guidance techniques were observed – educators providing choices, educators using positive language, and educators taking part in conversations and play.
