General Comments

For administration of Tylenol, ensure the form being used is Appendix 8- Administration of Acetaminophen Record.

Ensure pencils are sharpened daily so they can be used (2 year old room).

Discussed with older infant educators possibilities for transitioning from indoors to outdoors that support children and educators. Expectations for children to sit at this age for longer than a minute or two can cause frustration and challenging behaviours. Recommend that once children are undressed, one educator sits and reads or sings with the children as the other hangs up their outdoor clothing. Also recommend that one educator position themselves at the entry to the hall so that the children are not leaving the cubby area,
