Comments: Visit occurred on July 26, 2022 to address concerns regarding positive child guidance. Positive child guidance techniques were not being used in the 15-23 month age room. During visit to facility on July 26, 2022, it was observed one educator in the two year old room speaking in a harsh tone to the children in her care. Was immediately addressed with administrator who indicated she spoke with the educator.

Comments:	Through conversations with educators it has been determined that positive child guidance techniques were not being followed and the facility did not ensure that no child sustain physical punishment, verbal or emotional abuse. It has also been determined that the operator of the childcare facility did not prevent this from occurring when educators addressed this concern with them.							

General Comments

Name of operator

Scheduled visit with the operator to discuss concerns regarding Child Guidance practices within the facility. In accordance with the Family Services Act, section 30(1), there is a duty to report child abuse.

"Any person who has information causing him to suspect that a child has been abandoned, deserted, physically or emotionally neglected, physically or sexually ill-treated, ...shall inform the Minister of the situation without delay."

All staff members are to be aware that mandatory reporting of child abuse is required under the Family Services Act and that a report to the Department of Social Development is necessary.

It has been concluded that the operator has failed to act on staff concerns of child abuse and failed to notify the Department of Social Development as well as the Department of Education and Early Childhood Development

General Comments
(licensing staff).
The operator has the responsibility to set clear policies for staff members that abusive behaviours are not tolerated. The operator is to establish procedures for dealing with staff members who are suspected of abusing a child, such as:
*dismissing any staff member who uses physical punishment, or who verbally or emotionally abuses a child, or withholds any physical necessity;

*reporting the incident to the Department of Social Development who determine next steps;

*informing ELC licensing staff of any abuse of a child by a staff member; and

*completing an Incident Report form (Appendix 12)

All staff must review section 8.2 Child Guidance in the Operator Manual and sign off that they understand their role in keeping children safe. This is to be maintained in each staff file and dated.
