Comments: During the time of the follow-up inspection, the name, address and telephone number of the medical practitioner was indicated in all the audited children's records. Deficiency is now compliant

Comments: In one of the audited children's records, the full address was not indicated for the emergency contacts (the town and postal code were missing). The full address of 2 emergency contacts must be placed in the child's file in order to ensure that they are able to reach the facility within one hour in case of emergency. All children's files will need to be verified.
