## **General Comments**

A renewal inspection occurred today. The children were observed during inside play, gym activities, outside play, lunch, and quiet/nap time.

Handwashing and diaper changing were observed occurring several times during the inspection.

Discussed with educators and administrators that the use of shaving cream with young children should be limited to inside a bag for sensory due to container indicating "keep out of the reach of children". Also, that young children put items in their mouths and shaving cream is not to be ingested. Administrators indicated they would be removing it completely from the floor going forward and using other items for sensory.

## **General Comments**

The gym area as well as the outside play area were inspected during the visit.

The children's learning is evident as it is posted throughout each of the early learning environments.

The preschool age rooms are set up with a variety of age-appropriate materials for the children to interact and engage with. The school-age room (cafe) is also set up with items that are age appropriate, and their artwork is displayed on the walls to enhance the area.

Educators were observed having positive and respectful interactions with the children in their care.
