A discussion was had with an educator, who indicates that these mats are not used frequently. When they are used, the educators ensure that they are covered with a sheet and that it is the same childre who use each mat, to reduce the risk of communicable disease. A receipt was shown to the inspector to show that new rest equipment has been purchased to replace these. Educator indicates that the order has not yet arrived. Once the order is received, Operator must send proof to the inspector.
