The indoor environment is purposefully planned with a variety of materials and interest centres for the children. Dramatic play is currently set up as a grocery store with food boxes and containers for the children to buy, and has authentic aprons and coats from a local grocery store.

The creative art centre has a variety of loose parts, different colours and sizes of paper, a variety of mark making tools, glue, and scissors.
