General Comments

Renewal Inspection:

The school-age children were observed playing outside when the Inspector arrived. The children were observed playing in all areas of the outdoor play space. The Educators were observed spaced out around the yard ensuring proper supervision. A group of children were observed playing on the stationary equipment, swinging on swings alongside their Educator. Another group of children were observed digging tunnels and playing in the dirt. The children were observed using a variety of tools in the large dirt pile such as, muffin tins, rakes, shovels, bowls, and utensils.

The children have been divided into two groups "Flip" and "Flop". The Educators shared that they came up with the name after a child was struggling with transiting to and from snack time. The children were observed washing hands before having snack. Flip sat for snack first while Flop played on the gym side. Once Flip was done, Flop was invited for snack and Flip went to the gym side.

General Comments

Transitions were smooth. A documentation binder was created documenting past and present activities.

The following records were reviewed: Incident logs, fire drills, and daily attendance sheets. A monthly review and maintenance plan was completed on all stationary equipment.

All staff files were viewed, and a random review of the children files was completed.

The Inspector discussed with the Administrator ensuring that all required staff documents are transferred from site to site.
