Name of operator

Children were playing outside when I arrived for today's monitoring inspection. Children were observed playing with basket balls, on play structures, chalk, bubbles, etc. Educator created a life-size snakes and ladders board for the children to play with. Many children were observed enjoying using themselves as board pieces while climbing up chalk drawn ladders and sliding down chalk drawn snakes.

Educators were observed interacting with children throughout the entire time of visit. They were observed bringing craft supplies outside, sitting with the children and partaking in the craft, playing basketball, playing several games of "build-a-man" with the children in the school's outside classroom, pushing them on the swings, etc.

Children all wear green "Go-Go pinnies" while outside. This helps educators easily identify children who are in Go-Go's care while using a public/school playground. Educators were observed performing several head

counts, and ensuring they were moving around the large outside play space to ensure proper supervision of the children.

Observed an educator ID an individual during pick-up time, ensuring that the child was released to only approved individuals.

For safety reasons, Go-Go is still ensuring children stay off the red play structure that appears to be rusted.

Facility's licensed indoor play spaces were not available to them today due to a school production going on in the gym.

The main licensed rooms for Go-Go After School Park Street are 15 spaces in the library and 30 in the gym. For September, please provide licensing staff with the required documents to confirm alternate rooms (for a total of 45 spaces) that children and staff can use should their regular licensed locations be unavailable to them during the upcoming school year. A letter of agreement for all licensed rooms between Go-Go and the school will also be required at this time.
