Deficiency is now compliant as the educator no longer works here.			

<p><b>General Comments</b></p> <p>Monitoring Inspection:</p> <p>A monitoring inspection was conducted in the afternoon for the school-age program.</p> <p>The school-age children were observed arriving from school. Upon arrival, children washed their hands and took turns changing in preparation for swimming. They were also observed applying sunscreen. Once ready, the children engaged in play within the various learning centers in the room.</p> <p>Educators were observed actively supervising children at their designated changing areas. Once all children were prepared, educators escorted the group to a public pool for swimming.</p> <p>The inspector discussed with the on-site administrator the requirement for a reduced swim ratio of 8:1, and ensuring that first aid supplies, government attendance records, and emergency contact information were brought by educators during the outing.</p>
