| General Comments | | | | | | |

During the licensing renewal visit the licensing staff observed the children engaging in open ended activities. The children appeared happy in all rooms. They were engaged in play and with the educators. It was also observed that the babies went outside for outdoor play during this visit. Please ensure that children in all age groups are engaging in outdoor play in the morning and the afternoon.

When observing in the infant room it is noted that the change table was not within 1 meter of a sink. The Operator immediately moved the change table just outside the bathroom door in order for regulation regarding diaper changing to be met.

General Comments

When reviewing the staff files it is noted that the 50 percent of the staff do have the required qualifications but the Operator/Administer is currently taking her ECE course and will graduate in 2021.

When licensing staff went to check on storage of the toxic products it was noted that the door to the kitchen was unlocked and the keys were in the lock in the door. The Operator immediately removed the keys out of the door and placed them on a nail that it is located on a wall up high near the kitchen door. It was then again noted later by licensing staff that the door was left wide open again.

When inspecting the outdoor play space it is noted that there is a protruding nail on a post located at the back of the playhouse. Also it is noted that there is standing water in the tires that are located on the ground inside the play area. Surfacing is to meet 30cm depth in all areas of the encroachment zone. If this is not possible before snow fall, it is recommended that children not be permitted on structure.

A change in service inspection is in process for the change in allocation of space.
