This was a follow up to a previous visit in the spring.

Upon arrival I observed all children playing outside in the outdoor play area - 18 children in total with one staff. I observed 2 staff coming from indoors and they entered inside the gated outdoor play area. I asked if anyone else was in the building and one educator said 'yes there is one indoors, but all the children were outdoors'. I went inside but I could not locate the staff, so I returned outdoors. One of the staff collected her children and moved inside soon after my arrival. 16 children and 3 staff remained outdoors until 11 AM. Staff child ratio must be maintained during all hours of operation and infants are not to be mixed with preschool age. I observed staff taking their group for bathroom breaks during my visit maintaining ratio in the outdoor play area.

## General Comments

It is important to prepare the indoor and outdoor play area to meet the curriculum needs and interests of the children. I did not observe a lot of programing happening in the outdoor play area during my visit. I also noticed that many of the programming rooms were sparse and need a lot more toys, equipment and other materials to enhance and extend learning opportunities. I would like to see staff bring indoor materials to outside - books, art, water and sand play etc.. Not all children need to be outside at the same time and this would allow educators to engage, interact with their group and provide fun educational activities that are developmentally appropriate. I realize the forecast is a high heat alert today and I expect staff wanted to ensure children had an opportunity for outside play in the AM. I believe this could have been easily accomplished with a bit of planning.

Staff were very helpful during my visit, but administrative records need to be stored and available for departmental staff. A few records were located during my visit and I have indicated that in the above compliances. TY.

It would be the expectation that items would be replenished for the beginning of the day - paper towel in the dispenser, new bathroom cleaning schedule posted for the week, storage closet locked and your room purposefully planned. I observed a Tim's coffee cup on the shelf which suggests staff were drinking hot coffee in the programming room. Please refrain from drinking hot beverages where children play. TY. Please contact your fire inspector and request an inspection as the department is unable to issue a renewal license, though it remains in continuation until an inspection report is received. TY.
