Comments: During the file review, the Quality Assurance Monitor noted that one file was missing the signed declaration. All staff member's files must include a signed statement regarding their obligations under the Act and licensing regulation. The operator must ensure that all staff members' files are complete.

Comments: During the monitoring inspection, the Quality Assurance Monitor noted that the keys to the locked cabinets where medications are stored were left in the lock. The facility must ensure that medications are kept in a locked storage space that is inaccessible to children. The administrator immediately removed the keys from the lock and put them away. Deficiency is now compliant

General Comments

During the inspection, the child-to-staff ratios were maintained. The Quality Assurance Monitor observed free indoor play. Positive interactions between staff and children were also noted, such as educators getting down to the children's level to engage in play and others hosting a dance party with their group.

The Quality Assurance Monitor had a discussion with the administrator regarding administrative records that must be kept on site. Although the administrator was aware of their importance and mandatory nature, the Quality Assurance Monitor was unable to observe the fire drill records or the outdoor play area maintenance records. The administrator informed the QAM that these items were on her to-do list for this week and would be prioritized.

A discussion was also held regarding designation requirements. The administrator informed the QAM that all eligible staff are actively completing their professional learning hours. A recent change was made to the Board of Directors, and the Quality Assurance Monitor is still waiting for one vulnerable sector check from a member. A friendly reminder was given to the administrator, and a copy of the check can be sent to the QAM as soon as it is completed.

During the visit, the QAM was informed that the facility no longer offers lunch and now only provides snacks. The QAM reminded the administrator that an application for change must be submitted to the department in order to remove services.
