Comments: Group logs (Appendix C):Not being completed accurately. Most group log forms were missing date and date group established was not being recorded accurately. Discussed with operator and educators. Ensure any person who enters the room is recorded on the group log. The operator is to ensure that the relief personnel is a consistent person within the facility and within the groups of children they support. Diaper changing: Educator did not follow diaper changing procedure outlined in Appendix 22. Disinfecting solution must be left for 2 minutes prior to wiping with paper towel and then must be rinsed with clean water prior to wiping with paper towel. Please review diaper changing procedure with staff. Garbage can for diapers within change station washroom did not have a lid today. This was corrected during time of inspection. Serving meals: Staff member from another facility entered building and transported lunch from the kitchen today. Have a specific staff delegated to prepare and serve meals in order to minimize unnecessary contact. This should be a specific staff member from that facility, and not another site. If the educator within the room is to plate the food, this should not be done at the children's table to avoid potential contamination.

Comments: Cord dangling from stereo on shelf within 4 year old room today. Cord to be affixed to wall or stereo moved to another location to prevent dangling. This was removed during time of inspection.

Comments: Nail heads protruding from tower structure within outdoor play area. To be fixed as soon as possible. A portion of caterpillar tunnel structure and bench on plastic picnic table in front outdoor play area is covered in duct tape-to be replaced or removed.			
32(1) An operator of a licensed facility shall provide indoor play area materials and equipment that are (d) clean and in good repair.	32(1)(d)	Jul 14, 2020	
Comments: Kitchen center within middle room accumulating debris and unclean (previous comply by date of Feb. 6/20). Hair salon kit and plastic doll high chair within this room is also unclean. Toys and other high touch surfaces should be cleaned and disinfected at least twice daily (as per COVID-19 Recovery Phase document).			

General Comments

Monitoring Inspection COVID-19 Recovery Phase.

Screening protocols were followed upon entry to facility.

Children were engaged in conversations and activities within their groups today. The indoor environment demonstrated a variety of the children's interests (dramatic play, art displayed on walls).

Outdoor time was observed. Educators had sanitizing solution outside in play area to disinfect toys between uses.

Hand washing routines observed today.

A healthy lunch was served during the time of inspection.

Three separate groups of children share the washrooms within the Clubhouse. In order to access the washrooms, the children must walk through another groups space. A distance of 2 m between groups must occur at all times. Washrooms must also be sanitized between groups.
